Preceding him in death were his parents; his wife, Dorothy (Henschel) Scott, whom he married April 12, 1947, and who died April 6, 1997; a sister, Verna (Scott) Hall; and a brother, Frank Scott.

RECIPE OF THE MONTH

Wild Rice Turkey

Ingredients

- 1 (6 ounce) package long grain and wild rice mix
- 3 cups cubed cooked turkey
- 1 (10.75 ounce) can condensed cream of chicken soup, undiluted
- 1 (8 ounce) can sliced water chestnuts, drained and halved
- 3/4 cup water
- 1/4 cup chopped onion
- 3 tablespoons soy sauce
- 1 cup soft bread crumbs
- 1 tablespoon butter or margarine, melted

Directions

1. Prepare rice according to package directions. Stir in the turkey, soup, water chestnuts, water, onion and soy sauce. Transfer to a greased 2-qt. baking dish. Cover and bake at 350 degrees F for 30 minutes.
2. Uncover. Toss bread crumbs and butter; sprinkle over the top. Bake 15-20 minutes longer or until bubbly and golden brown. Let stand for 15 minutes before serving.

PAPER CHASE

If you remember reading the October 2008 issue of the Radiogram, you probably remember that its editor, Tom KB8UUZ a.k.a. Parky, had an article about the "Year of the State QSO Party." How are you doing? Did you forget about it? For your information, there is only one QSO Party remaining, Kentucky on November 14th.

The rules were simple, work all the states during the year during their QSO Party or you can substitute an ARRL or NCJ contest contact after the State QSO Party had passed. The only sticky point is that you had to submit a log to claim the state. Check your records; you may be closer than you thought.

If you are close, not so close or have not even started; all is not lost. There are four contests coming up that bring out the stations in large numbers from all the states. The contests are: Sweepstakes, CW November 7th & 8th and Phone November 21st & 22nd; and ARRL 160 Meter (CW), December 4th and 5th and the ARRL 10 Meter, December 12 & 13. Depending on the propagation it may be easy or pose a challenge. GOOD LUCK!

The Certificate is colorful and you might just want to print it and the accompanying flags. Go to the ARRL web site and type "Year of the QSO Party" in the search function and it will provide you with the instructions and the links for you to download the certificate and flags. Use it to show yourself how many of the states you worked during the last year; or as Mike, KC8UNR, is using it to show the states he has confirmed as he works for his "Worked All States (WAS)". Keep it next to operating station and it is a reminder what states you still need

It is that time of the year again to start thinking about the annual meeting. The following article is a description of each office that will be up for election. The annual meeting will be held in place of the second meeting in January. This meeting will be on January 19, 2010 starting at 7:30pm. please remember that your dues must be up to date to be elected to an office or to vote. If you have not paid next years dues please see our present Treasurer Betsy Williams KD8BIB at any meeting or they can be mailed to P.O. Box 809, Warren, Ohio 44483. The dues are still only \$10.00 a year...
The above description is not in any means complete for each office it is just a summary

President: To open the session at the time at which the assembly is to meet, by taking the chair and calling the members to order; to announce the business before the assembly in the order in which it is to be acted upon; to recognize members entitled to the floor; to state and to put to vote all questions which are regularly moved, or necessarily arise in the course of the proceedings, and to announce the result of the vote; to inform the assembly, when necessary, or when referred to for the purpose, on a point of order or practice pertinent to pending business; to authenticate, by his signature, when necessary, all the acts, orders, and proceedings of the assembly declaring its will and in all things obeying its

Commands
Vice-President: If it is necessary for the President to be absence then the Vice President, if there is one, should take the chair and Calling the members to order; to announce the business before the assembly in the order in which it is to be acted upon; to recognize members entitled to the floor; to state and to put to vote all questions which are regularly moved, or necessarily arise in the course of the proceedings, and to announce the result of the vote; to inform the assembly, when necessary, or when referred to for the purpose, on a point of order or practice pertinent to pending business; to authenticate, by his signature, when necessary.

Secretary: The Secretary is the recording officer of the club, the custodian of its records except such as are specifically assigned to others, as the Treasurer's books. In addition to keeping the records of the club the minutes of the meetings, it is the duty of the secretary to keep a register, and to sign with the President all orders on the Treasurer authorized by the society, In addition to the above duties, when there is only one Secretary, it is his duty to send out proper notices of all called meetings, and of other meetings when necessary, and to conduct the correspondence of the society, except as otherwise provided. The Secretary should, previous to

each meeting, for the use of the chairman, make out an order of business, showing in their exact order what is necessarily to come before the assembly. He should also have, at each meeting, a list of all standing committees, and such special committees as are in existence at the time, as well as the by-laws of the organization and its minutes.

Treasurer: The duties of this officer vary in different societies. In probably the majority of cases he acts as a banker, merely holding the funds deposited with him and paying them out on the order of the society signed by the president and the secretary. He is always required to make an annual report. If the society has

auditors the report should be handed to them, with the vouchers, in time to be audited before the meeting. The auditors having certified to its correctness, submit their report, and the chair puts the question on adopting it, which has the effect of approving the Treasurer's report, and relieving him from responsibility in case of loss of vouchers, except in case of fraud.

If there are no auditors the report when made should be referred to an auditing committee, who should report on it later. It should always be remembered that the financial report is made for the information of members. The details of dates and separate payments for the same object are a hindrance to its being understood,

duty of the auditing committee to examine into details and see if the report is correct. The best form for these financial reports depends upon the kind of society, and is best determined by examining those made in similar societies. The following brief report is in a form adapted to many societies where the financial work is a very subordinate part of their work:

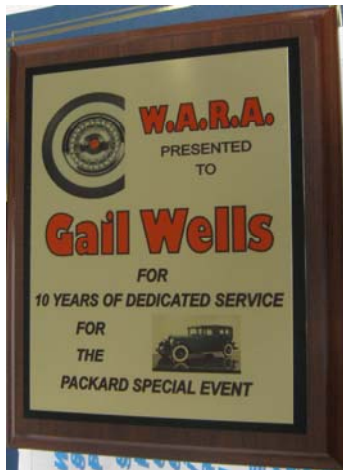
WARA ANNUAL BANQUET
